Ans The term 'democracy' which is drawn from the Greek words 'demos' means 'People' and 'kratos' means 'Government' means Power or Government of the People. Plato defined democracy as "a rule of ignorance". As Aristotle defined democracy as "the Government by the many Perverted souls." Abraham Lincoln gives a very simple, easy and Popular definition of democracy as "Democracy is Government by the People, of the People and For the People." According to MacIver, "Democracy is not a way of governing whether by majority or otherwise, but Primarily a way of determining who shall govern and broadly, to what ends." According to Lewis, "Democracy properly signifies a Government in which the majority of the whole nation or community is the Part of the Sovereign Power." Hearnshaw says, "Democracy is a mode of appointing, controlling and dismissing Government."

Ans Thomas Hobbes (1588-1679) was an English Political thinker. After completing his education at Oxford, Hobbes becomes a tutor in aristocratic households. For some time, he was private tutor to Charles. He lived in the stirring times of the Great Rebellion and the Commonwealth. He identified himself with the monarchist cause and concluded that the salvation of the country lay in an absolute system of government.

The condition of life in the state of nature reached an intolerable stage. People entered into a contract in order to protect their life and maintain peace. As a result of this contract, people gave up their rights except the right to self-preservation to one man or a body of men and authorised him or the body to rule over them. He was called the sovereign.
