## **6. An International Webinar on Law and Social Transformation Post Covid-19**

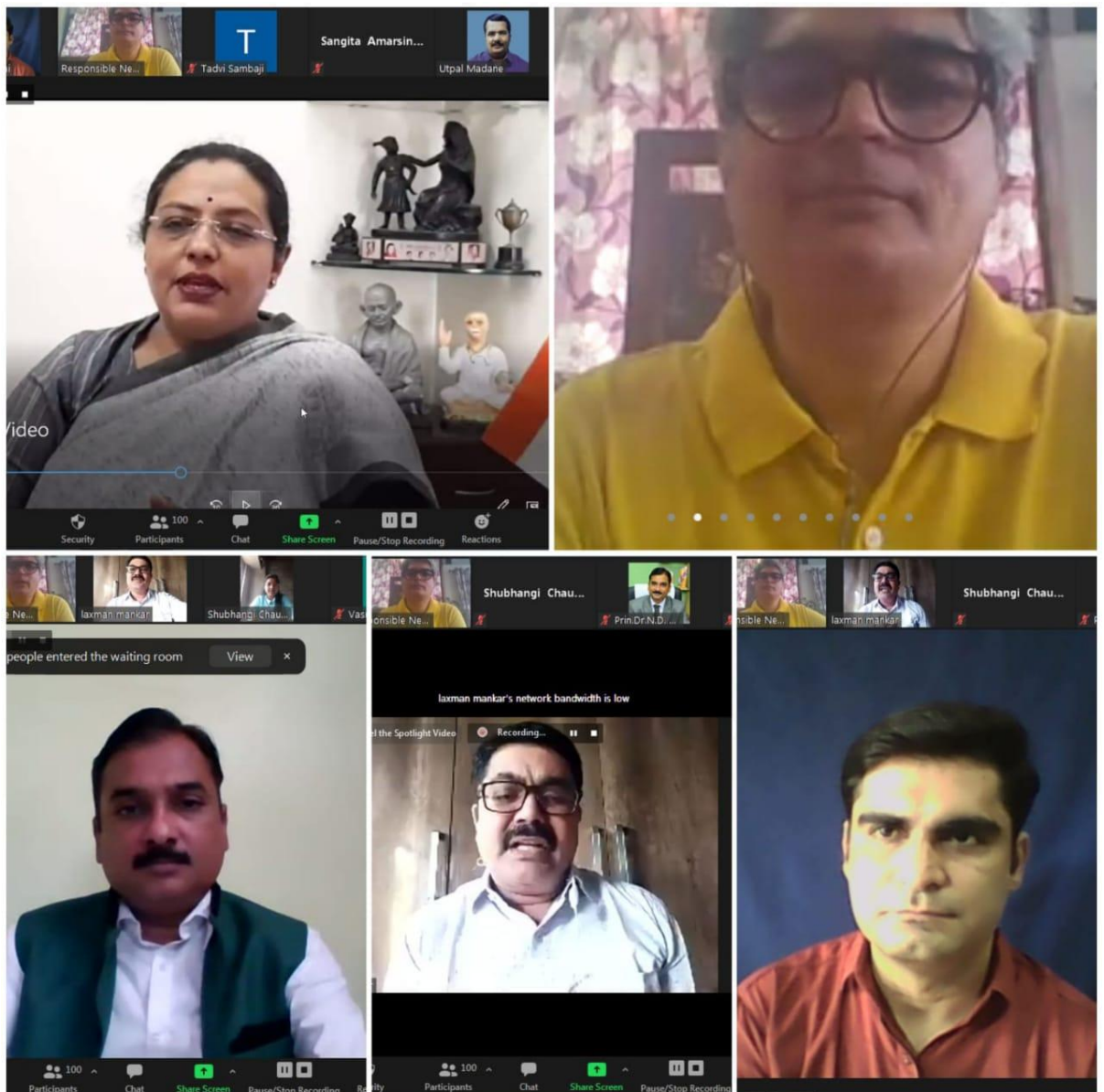

## 16. Three Days Online Training Programme on Intellectual Property Rights

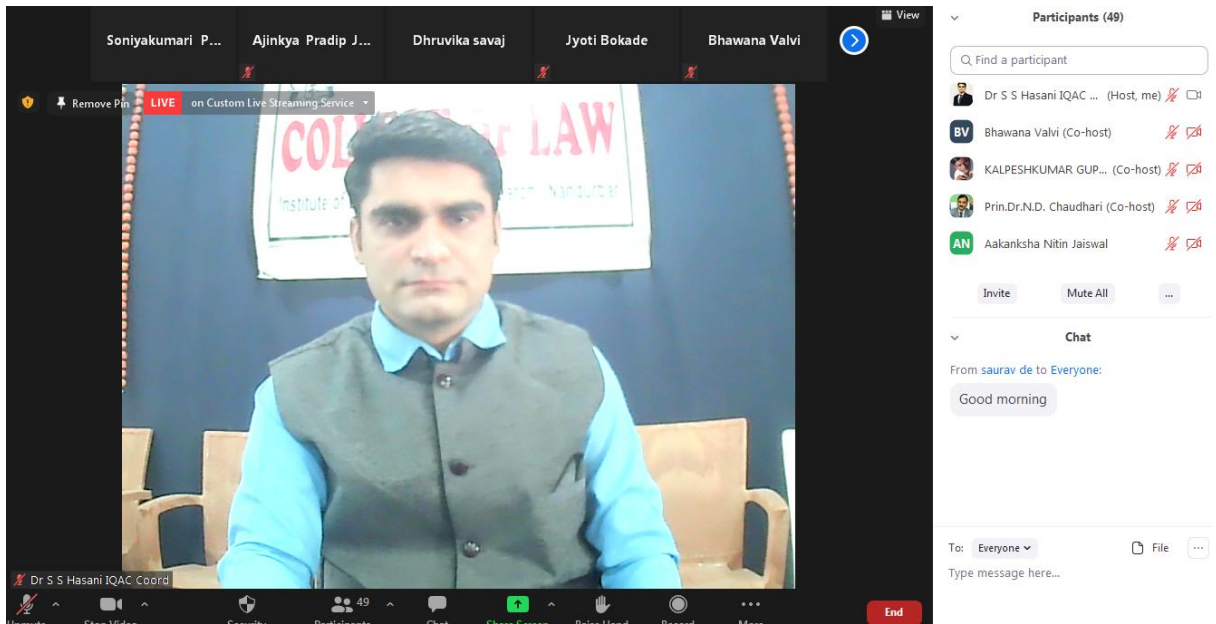
